In consideration of use of the tanning services, I _____ release, acquit and forever discharge understand B-B-G Housing Corporation dba Campus View Apartments & Townhomes, and/or their officers, directors, employees, agents, shareholders, affiliates, volunteers, contractors, successors and assigns of all claims, demands, causes of action, and damages in relation to use of the tanning services.

I acknowledge all of the following:

- Not wearing eye protection while using a tanning device may cause damage to the eyes.
- Overexposure to the ultraviolet radiation produced by the tanning devices used in the tanning facility causes burns.
- Repeated exposure to the ultraviolet radiation produced by the tanning devices used in the tanning facility may cause premature aging of the skin or skin cancer, or both.
- Abnormal skin sensitivity to ultraviolet radiation or burning may be caused by certain foods, cosmetics, and medication. The medication includes, but is not limited to, all of the following: Tranquilizers, Diuretics, Antibiotics, High blood pressure medication and/or Birth control medication.
- An individual who is taking a prescription drug or over-the-counter drug should consult a physician before using a tanning device.
- An individual that suffers an injury while using a tanning device at a tanning facility must report the injury to the owner or operator of the tanning facility.
- That any skin-related treatment involving microdermabrasion, including, but not limited to, facials, waxing, or skin peels, may cause abnormal sensitivity to ultraviolet radiation.
